

BARNAAMIJKA ILAALINTA BIXINTA MUSHAARKA GANACSIYADA YAR-YAR

Barnaamijka bixinta mushaaraadka wuxuu siinaya ganacsiyada yar-yar lacag eey isaga bixiyaan ilaa 8 isbuuc/todobaad kharashaadka mushaarka taasoo eey kujirto faa'iido. Waxaa sidoo kale loo isticmaali kara lacagta bixinta dulsarka deenya, kirada, iyo waxyaabaha kale sida korontada, biyaha iyo kharashka teleefoonka.

Si-buuxda Loo-cafiyay

Deeqda lacagta waxaa lagu bixin doona qaab deny/amaah ah taasoo si-buuxda loo-cafin doono hadii loo-isticmaalo kharashka mushaarka, dul-saarka denya, kirada, iyo waxyaabaha kale sida korontada, biyaha iyo kharashka teleefoonka (sabab laxiriirta rukumasho sareeyso, boqolkiiba 75% cadadka lacagta waa qasab in loo-isticmaalay mushaaraadka). Bixinta Deeyamaha waxaa dib-loodhigay lix bilood. Majiro wax rahmada ama damaanad shaqsiyadeed oo loo-baahanyahay. Dowlada iyo deeyn bixiyayaasha midkoodna kuma dalacaayo ganacsiyada yar-yar wax khidmada.

Waa Inuu siibixiya Mushaarka Shaqaalah —ama Dib-ugu-shaqaaleeysiyya si-Dhaqsa

Cafintu waxeey ku saleeyasantahay loo-shaqeeyaha inuu xakameeyo ama si-dhaqsa inuu-dib-ugu shaqaaleeysiyyo shaqaalah iyo xakameeyo heerka mushaarka. Cafintu waaladhimi-doona hadii eey is-dhinto tirada u shaqeeysa maalinki, ama hadii uu hoos u dhaco mushaarka iyo gunada.

Waa u-Qalmaan Dhamaan Ganacsiyada Yar-Yar

Ganacsiyada yar-yar ee leh shaqaalah 500 ama kayar —oo eey kamid-yihiin heey'adaha, ururada halyeeyada, u-doodayaasha walaacyada qabiilada, shaqsiyaadka iskood u shaqeesta, ganacsade kaligiisa, iyo qandaraaslayaasha madaxa banaan—weey u-qalmaan. Ganacsiga leh shaqaale kabadan 500 weey u-qalmaan warshadaha qaarkood.

Goorme Ladal-bankaraa

Laga bilaabo April 3, 2020, ganacsiyada yar-yar iyo ganacsadaha kaligiiska ah weey dal-bankaraan. Laga bilaabo April 10, 2020, qandaraaslayaasha madaxa banana iyo shaqsiyaadka iskood u shaqeesta weey dalbankaraan. Waanu idinku dhiiri-galineeyna sida ugu dhaqsiyaha badan ee aad awodo maxaa yeelay waxaa jira maalgelin xadidan.

Codsadaha waxuu u qalma inuu helo deeyn u ogolaanaya sharcigan kaasoo dhaqan galaaya waqtiga lagud biyay codsigaan taasoo loo soo saaray maamulka ganacsiyada yar-yar (SBA) ayaa hirgelineysa Barnaamijka Ilalinta Mushaar bixinta hoostagana qeeybta A, Ciwaanka I ee gargaarka Coronavirus , Caawimaada, iyo Xeerka Amniga dhaqaalaha (xeerka DARYEELKA) (Sharciga Barnaamijka Ilalinta Mushaar Bixinta).

Cosadaha (1) waa qandaraasle madax-banaan, una qalma shaqsiga kaligii shaqeesta, ama ganacsada kaligii shaqeesta ama (2) shaqaaleysiya 500 kabadan ama shaqaale ama , hadii lagu dabaqi-karo, ama qiyaasta heerka tirade shaqaalaha ku aasaastay SBA ee 13

C.F.R. 121.201 codsadaha warshada.

Waan u hogaansami doona, markasta oo lagu dabaqi karo, xaqquqda madaniga iyo xadidaada kale foomkaan.

Dhamaan horay u wadida deeynmaha SBA waxaa loo-isticmaali doona wixi laxiriira-ganacsi kaliya ujeedadana waxeey ku qeexantahay foomka codsiga deeynta iyo joogteey neeysa Sharciga Barnaamijka Ilalinta Musharka .

Ilaa-inta suurta gal ah, Waxaan soogadan doona kaliya qalabka iyo badeecada Mareekanka-sameeyaan.

Codsadaha kuma hoolana hoolo sharcidaro ka ah dowlada dhxey, maamul goboleed ama sharciga maxaliga.

Deeyn kasta oo uu codsadaha kuhelay sharciga 7(b)(2) ee xeerka ganacsiyada yar-yar inta u dhxeeysay Janaayo 31, 2020 iyo April 3, 2020 oo ah ujeedo aanan aheyn bixinta kharashaadka musharka iyo waxyaaba kale loo ogolyahay in loo isticmaalo deenyta ee Sharciga Barnaamijka Ilalinta Musharka.

Codsada yaasha ah Shaqsiga: Waxaan u ogolaanaya inu kacodsado SBA diiwaanka macluumaadka laxiriira danbiyada ee igu saabsan heey'adha cadaalada dambibiyyada taasoo ujeedadeeda tahay go'aan kagarida u qalmideeyda barnaamijkaan ogolaaneeyso xeerka ganacsiyada yar-yar, sida wax looga badalay.

TASTIIQDIN

Matalaayaayaasha loo ogolaaday codsiga waa iney ugu cadeeyaan si-niyad wanaaga dhamaan hoos **uguna kala horeysiinaya** midba midka kuxiga:

— Codadsaha wuu shaqeeynaayay February 15, 2020 iyo waxaana u joogay shaqaale kuwaas uu siinaayay mushaar iyo bixinaayay canshuur ama siinaya lacag qandaraaslayaal madax-banaan, sida lagu weriyay/waarday foomka (s) 1099-MISC.

— Hubin la'aanta dhaqaale ee xiligaan ayaa codsiga amaahdaan kadhigeeysa lagama maarmaan si loogu taageero horay u socoshada hoosha ee codsadaha.

— Lacagta waxaa loo isticmaali doona sii heeyashada shaqaalaha iyo xakameeynta mushaar bixinta ama bixinta dulsaarka deeynta, bixinta kirada, iyo bixinta waxyaabaha kale sida korontada, biyaha iyo telefoonka, sida lagu qeexay Sharciga Barnaamijka Ilalinta Mushaar bixinta; Aniga waan fahmaaya midaa hadii lacagta iyadoo lo ogyahay loo isticmaalo ujeedooyin aan ogoloaansho heeysan, dowlada dhxey waxa laga yaaba iney sharciga ila tiigsato, tusaale sida ku xukmida qiyaamo.

— Codadsaha waxuu deeyn bixiyaha siin doona dukumiinti xaqiijinaya tirade saxda ee u dhiganta shaqaalah si buuxda u shaqeeya maalinki o dhan ee u qoran mushaar bvixiyaha sidoo kale cadadka kharashka musharka doolar ahaan, bixinta amaahda dulsaarka guryaha, bixinta amaahda kirada, bixinta amaahda kirada iyo bixida waxyaabaha kale mudo sideed todobaada ee laxiriira amaahdaan.

— Aniga waan fahamaya amaah cafinta waxaa labixin doona isugeeyn kharashaadka musharka dukumiintiyeeysan, bixinta amaahda dulsaarka guryaha, bixinta amaahda kirada, iyo bixinta waxyaabaha kale, taaso aan kabadneen boqolkiiiba 25% ee cadadka lacafiyay waxaa laga yaaba iney tahay kharashaadka aan aheeyn musharka.

— Inta lagu jiro mudadaan laga bilaabo February 15, 2020 iyo dhamaadka December 31, 2020, Codadsaha mahelin iyo mana helidoono amaah kale oo ah Barnaamijka Ilalinta Mushaar bixinta.

— Waaan sii xaqiijinaya macluumaadka aan kubixiyay codsigaan iyo macluumaadka aan kubixiyay dhamaan dukumiintiyada taageeraya iyo foomamka wa run iyo waa sax dhamaan waxyaalaha loo tixgeliyo. Waan u fahmay si ogaala sameeynta bayaan been ah oo aan sax aheeyn si aan ugu helo amaah SBA waxeey ka mudan tahay ciqaab xaga sharciga, kaasoo uu kujiro 18 USC 1001 iyo 3571 ee xabsi aanan kabadneen shan sano iyo/ama ganaax ilaa \$250,000; iyo sharciga 15 USC 645 xabsi aan kabadneen laba sano iyo/ama ganaax aanan kabadneen \$5,000; iyo, hadii loo gudbiyo hee'ad federaala oo ceeyimiska kujirto, ee 18 USC 1014 oo ah xabsi aanan kabadneen sodon sano iyo/ama ganaax aanan kabadneen \$1,000,000.

Ujeedada Foomkaan:

Foomkaan waxaa buuxiyay wakiilka codsadaha waxuuna **ugudbiyaya SBA amaahiye kaqeeyb galaya** Soo gudbinta codsiga macluumaadka waxeey u baahantahay iney go'aan kagaarto laxiriira u qalmida taageerada dhaqaale. Ku guul dareeysiga soo gudbin la'aan waxeey sameeyneesa go'aan gaaristaas.

Tilmaamaha buuxinta foomkaan:

Laxiriirta "ujeedada amaahda," kharash bixinta waxeey ka koobantahay magdhowga shaqaalaha (kuwaa soo degenaashahooda koowaad/guud yahay mareekanka) foomka mushaarka, gunada, qoondo, ama lamida magdhow; lacag dheeriya ama mid lamida (taasoo ku saleeysan diiwaanka shaqaaleeysiyyaha ee lacagaha dheeraadka ee laga sootagay ama, maqnaashaha diiwaanka nuucaa ah, macquula, niyad-wanaaga loo shaqeeyaha wawa lagu qiyaasi karo lacagta dheeriga uu bixiyo); lacagaha fasaxa, waalidka, qoyska, caafimaadka, ama fasaxa xanuunka; gunnada kala-taga ama ruqsada; lacag bixinta xirfada ee faa'iiddada shaqaalaha waxeey ka koobantahay bixinta daryeelka caafimaadka ee koox, oo eey kujirto ceemiska sanadlahaa, iyo hawl-gabka; bixinta canshuurta gobolka iyo mida degmada taasoo loo qiimeey naayo magdhowga shaqaalaha; iyo qandaraasle madax-banaan ama ganacsade kaligiisa, mushaarkoonda.daqli, ama dakhliga ka soogala qof kaligi shaqeesta ama magdhow lamida.

Ujeedada Xisaabinta "Isku celcelis mushaarka bilaha," inta badan codsodayaasha isku celcelis mushaarka bilaha ee 2019, marka laga reebo kharashka kor u dhaafaya \$100,000 kaaasoo sanadle laga dhigay ee shaqaale kasta. Ganacsi xiliyeedka, codsadaha waxuu doorana gelinta celceliska bishii xiliga inta u dhaxeesya February 15, 2019 iyo June 30, 2019, marka laga reebo kharashaadka kor u dhaafaya \$100,000 taasoo lagu saleeyay sanad ee shaqaale kasta. Ganacsiyada cusub, celceliska mushaarka bishii waxaa laga yaaba in loo xisaabiyo waqtiga inta u dhaxeesya laga bilaabo Janaayo 1, 2020 ilaa Febraayo 29, 2020, marka laga reebo kharashka kor u dhaafaya \$100,000 taasoo lagu saleeyay sanadle shaqaale kasta.

Hadii codsadaha dib u maal galinaayo dhaawaca dhaqaale ee musiibada deeynta (EIDL): Kudar lacagaha aan labixin ee EIDL lasameeyay inta u dhaxeesya Janaayo 31, 2020 iyo April 3, 2020, taaso kayar cadadka lacagta "horay" ee la hoos geeyay amaahda EIDL COVID-19 , codsashada amaah kuqor/muuji foomka.

Qeeyaha kala duwan ee hoos kutaxan waxaa lo tixgelinaaya milkiilayaal codsi sida ku qeexan 13 CFR § 120.10, sidoo kale "lacagi asalka aheyd":

Ganacsiga shaqsiga, ganacsadaha kaligi shaqeesta;

Ganacsiga iskaashiga, dhamaan iskaashatada guud, iyo dhamaan iskaashatada xadadan ee leh boqolkiiiba 20% ama kabadan lacagta shirkada;

Shirkadaha, dhamaan milkiilayaasha boqolkiiiba 20% ama kabadan shirkada;

Shirkadaha deeyn tooda xadidan tahay, dhamaan xubnaha leh boqolkiiiba 20% ama kabadan shirkada; iyo

Aamin uun (hadii codsadaha leeyahay).
